CATALOGUE DESCRIPTION:

This course focuses on families and communities as clients. Learning opportunities are provided which will enable the student to view persons as members of large social systems.

- d. Differentiate various theories used for family, group and community assessment.

Grades will be posted online using Moodle. It is a University policy not to give grades over the telephone. Please refrain from calling secretaries or student workers for grades. Marks on exam booklet will not be graded. No one is allowed to copy, photograph, tape record, or write questions or answers pertaining to an exam or quizzes. Violation of the university misconduct or academic dishonesty rules listed in the catalogue will result in appropriate action for dismissal.

TESTING RULES:

- Extra time for an exam is not permitted if students are late (see class attendance requirements).
- Students are expected to work independently on quizzes.
- Each quiz must be completed in Moodle within the set time limit. Quizzes are administered via Moodle under the corresponding Units (see Course Schedule).

CLASS ATTENDANCE REQUIREMENTS:

There is no in class meetings for 332. Check schedule and instructor's announcement regarding quiz times and refer to the course schedule for due dates.

Students should check Moodle daily for updates and messages. Faculty members are able to monitor the amount of time students spend on the course Moodle site. Students who have not

logged into the course within 2 days of the first class day will be contacted via email by faculty regarding course enrollment.

The School of Nursing conforms to the University Attendance Policy as outlined in the SLU General Catalogue. Attendance in scheduled classes is regarded as an obligation as well as a privilege. Faculty members will monitor weekly online attendance/participation, will keep attendance records for each course, and may withdraw any student for unexcused absences over 10% of total classes prior to the published withdrawal date. Following the published withdrawal date, a course grade will be assigned.

If a student has been removed from a class for non-attendance and wishes to reenter that class, he or she may appeal for readmission. The appeal will follow the grievance procedure. Students are referred to the General Catalogue and the Student Handbook. Grievance procedures are explained for alleged infractions, breaches of conduct, or failure to meet standards, requirements or rules.

Faculty reserves the right to determine if an absence is excused or unexcused. Excused absences will include but not be limited to: death of significant other, illness of student or dependent, accidents, authorized attendance at University activities. For an absence to be considered excused, students must call the nursing office or email the instructor before the beginning of class on the day of the absence. Students must submit appropriate documentation to their course faculty upon return to classes or clinical. Absences, excused or unexcused, are considered excessive if they interfere with the student's accomplishment of the course objectives. Clinical absences may not exceed one scheduled clinical week, as only one clinical make-up week is scheduled. Clinical absences may result in failure to meet course requirements due to inability to make up clinical time.

Tardiness (over 10 minutes late) is treated as an absence unless clarified with the instructor at the end of class. Tardy students may be required to wait outside the classroom until break before being admitted to class.

If a faculty member deems a student's absence excused, the student will be allowed to make up scheduled exams, class work or clinical time. Make up work and clinical time are scheduled at the discretion of the faculty and may be scheduled at the end of the semester, outside of regular class time.

Specific guidelines for student behaviors when class, clinical or examinations will be missed are detailed in course syllabi. Faculty within the School of Nursing set specific policies to the circumstances of the course or clinical agencies. If a student is ill on the date of an exam, the student must notify the instructor via email or phone PRIOR TO THE EXAM. If a student is absent on the day of a group presentation, the student must notify the instructor via email or phone PRIOR TO THE PRESENTATION. If the student is unable to contact the instructor, he/she should call the Nursing Department Secretary (985-549-2156) and leave a message. Contact the instructor no later than three (3) days after returning to school to present a written excuse to be considered for an excused absence. Make-up examinations and assignments are allowed for excused absences only. Make-up examinations and assignments may be an alternate form of the regularly scheduled exam or assignment. Faculty reserves the right to accept or

refuse late assignments. **ALL** late assignments (journals, quizzes, papers, discussion board, etc.) without a valid excuse per the instructor's discretion will receive a **ZERO**.

Self-plagiarism is the practice of using one's own previously published or written work as though it were new. The use of a single essay, paper, or assignment in more than one course will result in a **grade of ZERO** for the assignment and may result in disciplinary action.

CONDUCT:

Students are expected to comply with "Standards of Conduct" as outlined in the *SLU General Catalogue*. Academic honesty is an expectation of all students. Students should observe the following guidelines during all classroom sessions and when posting communications on the course Moodle site.

Students are expected to maintain proper "netiquette" during all online interactions. Netiquette involves maintaining a professional tone of respect and appreciation of each student and faculty. Students should carefully proofread all online posts/responses prior to submission to make sure others will not be offended or interpret them negatively. In addition, online interactions should not be offensive or considered as "crossing the civility line."

REPORTING OF SUBSEQUENT ARREST OR CONVICTIONS: After initial enrollment in the nursing major, any subsequent disciplinary action, arrest, charge, addition, or medical, physical, mental, emotional or psychiatric condition that might affect their ability to safely practice in the clinical setting and any diagnosis for dependence upon, or treatment for moodaltering substances, drugs or alcohol shall be reported IMMEDIATELY (within 24 hours) to the

School of Nursing Department Head and the Louisiana State Board of Nursing (LSBN) in the same manner as your initial application for progression for determination of continuance in the clinical component of nursing courses. Students may not report to clinical until the issue is resolved. Failure to report any and all subsequent disciplinary actions, arrests, or impairments may result in automatic dismissal from the School of Nursing, will ultimately result in denial of licensure as a registered nurse, and will constitute falsification of records.
